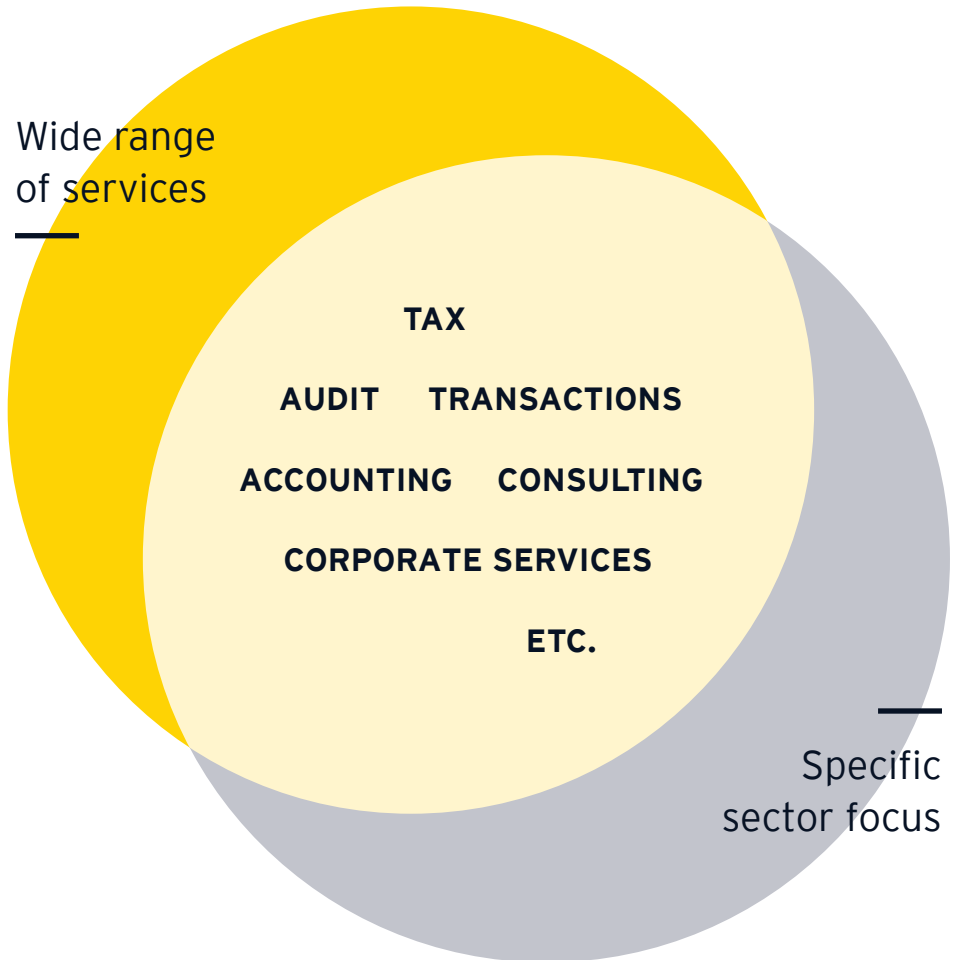
Our services
