UPDATE ON THE COMMENCEMENT OF THE DIRECTIONS APPLICATION AGAINST HODLNAUT TRADING LIMITED (IN CREDITORS' VOLUNTARY LIQUIDATION) ("HHK")

Dear Sir / Madam,

We refer to the subject matter above. We also refer to the 21<sup>st</sup> Circular (Liquidation) issued by the Liquidators on 18 September 2024, which in turn refers to certain earlier circulars previously issued by the Liquidators. Unless otherwise stated, we adopt the abbreviations used therein.

In the 21<sup>st</sup> Circular, the Liquidators provided an update that the Court had authorised the Liquidators to commence the Directions Application in the name of and on behalf of the Company, and that the Liquidators would file the Directions Application as soon as practicable.

We are writing to update that on 18 September 2024, the Liquidators and the Company filed the Directions Application (HC/OA 969/2024 ("**OA 969**")) against HHK, in the General Division of the High Court of the Republic of Singapore.

On 11 October 2024, the Liquidators and the Company also filed a sub-application for permission to serve the cause papers for the Directions Application on HHK in Hong Kong. The Court granted this application on 14 October 2024, and the Liquidators have served the cause papers on HHK in Hong Kong on 18 October 2024.

In the meantime, the Court has scheduled a case conference for the Directions Application on <u>14</u> <u>November 2024 at 2.30pm</u> (the "RCC"). The Court has further directed the Company and the Liquidators to provide an update on service by 11 November 2024.

The Liquidators will be instructing their legal counsel to attend the RCC. Please note that the RCC is not the substantive hearing of the Directions Application and is anticipated to be largely procedural or administrative in nature. Please also note that your attendance at the RCC is not compulsory, and we will provide you with a further update thereafter.
