

Effective date matrix as of 30 June 2024

Several accounting pronouncements are effective for the first time in 2024 for calendar year-end entities. This publication lists the effective dates of Accounting Standards Updates issued by the Financial Accounting Standards Board (FASB) as of 30 June 2024, including those effective after 2024, and provides links to related EY publications that are available free of charge on EY AccountingLink. Entities should monitor developments to determine whether any ASUs issued after 30 June 2024 are effective immediately. Other standard-setter and regulatory requirements (e.g., Securities and Exchange Commission (SEC) requirements) may also apply. All entities should carefully evaluate which accounting requirements apply to them for the first time in 2024.
