





#### WA and Qld have grown their share of the economy over the past 20 years








#### WA exports make up over 50% of all Australian exports





#### WA and the Northern Territory have the highest GSP per capita






# State governments expect some slowing in growth in FY23 and FY24, before a gradual recovery over the forward estimates





Retail Trade, Constant Prices y/y, % (bar); % change since pandemic (dot)





#### Inflation pressures are similar given the common sources of inflation








# All states and territories have record low unemployment rates of around 4% or below







#### Real wages have fallen in all states and territories in the year to December






#### The household expenditure to income ratio is highest in Tasmania

Average annual expenditure to annual median gross income ratio, 2015-16










#### Financial & Insurance Services is the biggest industry in NSW








Number of unemployed people for each job vacancy, New South Wales








#### The industry structure in Victoria is broadly based

Value of merchandise exports by industry of exporter (Victoria, FY20)










#### Healthcare and social assistance makes up more than 10% of the Qld economy

QLD industry share (FY22) and comparison to national industry share (Q3 2022)





Value of merchandise exports by industry of exporter (Queensland, FY20)





#### Qld has the highest population growth, driven by interstate migration














#### Rental prices on the Sunshine Coast are higher than Brisbane city











#### Queensland has benefitted from global price rises for its commodities




#### Mining makes up more than 45% of the WA economy





#### WA's population growth is strongly correlated to activity in the resources sector






Number of unemployed people for each job vacancy, Western Australia






#### Employment in the WA mining sector is at a record high reflecting strong levels of mining, construction and exploration activity in the state





SA industry share (FY21) and comparison to national industry share (Q3 2022)









ACT industry share (FY22) and comparison to national industry share (Q3 2022)




#### Tasmania has a strong focus on health care and agriculture









Number of unemployed people for each job vacancy, Northern Territory









